I. CONTEXT AND JUSTIFICATION

The history of Togo is characterized by socio-political crises and recurring situations involving serious violations of human rights, like many other countries that have opened themselves to the democratic process.

Women have been the first victims of this state of recurring violence of all kinds.

Given this context, it has been deemed necessary to regain control over the relationship between women, peace and security, and to take measures to ensure that women and young girls have adequate access to sanitary and humanitarian services, are protected from sexual and gender-based violence, and are given psychosocial and psychological support whenever required.

It is also necessary to ensure that reforming processes affecting the security sector take gender into consideration as a whole (defence, security and parliamentary forces, national structures responsible for justice, human rights, the promotion of women, etc.).

Within the framework of its peacekeeping and peacebuilding policies, the UN has taken measures to integrate gender into national policies with the objective of reducing the inequality that primarily affects women. In this regard, the UN has adopted Resolutions 1325 (2000) and 1820 (2008)¹, among other things, in order to protect women and young girls against violence in particular of sexual nature, to integrate gender into development programmes and policies, and to strengthen the participation of women in reconstruction and the peaceful resolution of disputes.

Another target objective is to better integrate women into political processes and decision-making. The founding of UN Women represents a concrete manifestation of this objective.

The desire to take gender into account expressed by the above-mentioned Resolutions 1325 and 1820 is shared by other international institutions, especially at regional and sub-regional levels. The AU adopted a Declaration on Gender Equality and ECOWAS has developed a Regional Action Plan for the implementation of Resolutions 1325 and 1820.

These different initiatives have been embraced by various organizations of women in Civil Society and Togolese Trade Unions which actively promote peace and security despite the lack of an applicable legal framework.

They have been expressed via awareness-raising, informational and training activities targeting the general public, opinion leaders, the media, the authorities, leaders of political parties, religious authorities, etc.

Examples include:

- awareness-raising activities by trade union women;
- organizations such as: ECHOPPE, Alafia, Mokpokpo and GF2D, and networks such as WILDAF, REPSFECO, REFAMP, which conducted campaigns against violence towards women:
- the "Togo World March of Women", which conducted an advocacy campaign for fundamental human rights and in particular those of women in collaboration with members of WILDAF;
- women of other religious denominations; they held debating conferences, talks, prayer campaigns, etc., and organized a Caravan for Peace;

two women's associations which represented civil society in the inter-Togolese dialogue that resulted in the signing of global political agreements. Women in trade unions also participated in social tripartite dialogue.

In order to ensure that their contributions to the process of preventing, managing and resolving conflict by peaceful means are meaningfully acknowledged, they sought the support of the United Nations System in Togo for the implementation and application of Resolutions 1325 and 1820 of the Security Council. These resolutions provide all organizations of women with the opportunity to gain access to a framework and valuable tools for developing effective action plans and thus achieving the desired objectives.

To this end, the State of Togo, women's organizations and trade unions have drafted an Action Plan in collaboration with the United Nations System in Togo in order to dynamically promote Resolutions 1325 and 1820.

II. DURATION

The National Action Plan for the involvement of women in conflict resolution and peacebuilding: strategies for the implementation of Resolutions 1325 and 1820 of the Security Council of the United Nations will run for five years, beginning on the date of its validation. However, a mid-term assessment is planned (after two years), and another assessment will be performed in the 5th year in the spirit of retrospective evaluation and critical examination of the progress achieved.

The National Action Plan may be revised or renewed for another period of equal duration according to the terms of the decision taken in this regard.

III. OBJECTIVES

General objective:

Increase the participation of women at all levels of decision-making, in particular in conflict prevention, management and resolution and peacebuilding.

Specific objectives:

a) Short-term objective (6 months)

In the short term, the objective is:

- to encourage effective and lasting negotiation-oriented solutions for permanently resolving conflicts and disputes.

b) Medium-term objectives (18 months)

The medium-term objectives are the following:

- To lead all parties to embrace the National Action Plan for the implementation of Resolutions 1325 and 1820 in a collaboration between all parties involved in this implementation;
- To conduct an advocacy campaign targeting the authorities for the adoption of the National Action Plan and the implementation of Resolutions 1325 and 1820, in collaboration with all involved parties;

- To develop the values and expertise of women on the subjects of culture, peace, the promotion of dialogue, and consensus-building in decision-making, especially in political contexts;
- To conduct an advocacy campaign for the inclusion of women into peacebuilding missions;
- To properly exploit women's expertise in negotiation techniques, peaceful conflict management, and the traditional modes and ethics of conflict resolution;
- To integrate special measures into national policies for increasing the capacities of women to contribute to conflict prevention and the promotion of peace culture by involving women in the development of these policies.

c) Long-term objectives (between 18 months and 5 years)

The long-term objectives are the following:

- To support and contribute to the Togolese programme of security sector reform as well as to reduce the circulation of small arms and light weapons;
- To study the causes of the recent violence inherent to the national political system; to conduct studies on local practices and traditions for settling disputes and promoting tolerance

- ➤ The monitoring and supervisory committee of CSOs/ministry will be established and equipped with executive means and structures.

b) Expected medium-term results

➤ Women will be provided with training on peaceful conflict prevention, management and resolution;

c) Expected long-term results

Togolese women will become key actors in decision-making in matters of conflict prevention, management and resolution in Togo.

VIII. RESOURCES

The implementation of this national action plan requires human resources as well as technical and financial means. To mobilize these resources, it will be necessary to rely on certain actors who are active in this area at both national and international levels.

IX. RESOURCE MOBILIZATION MECHANISMS

A committee of experts comprised of representatives from women's organizations, the government, and development partners will need to be formed to study resource mobilization strategies. The allocation of resources for the nation-wide implementation of Resolutions 1325 and 1820 will need to be negotiated and decided by this group of experts, after informing and consulting with all actors that might potentially be involved.

X. IMPLEMENTATION AND MONITORING/ASSESSMENT MECHANISMS

According to need, two distinct mechanisms can be established: one responsible for the execution of activities, the other responsible for monitoring and assessment of the executed activities.

For reasons of monitoring, it is therefore important to establish a permanent and independent executive committee within a designated Ministry which will be responsible for executing activities according to the agreed plan and which will require a permanent line of communication and regular exchange with beneficiaries and partners.

The second committee, which will be formed of leading women from civil society organizations, representatives of the ministry responsible for supervision and development partners, will ensure the monitoring and assessment of activities and will consult with all other actors involved in the implementation of the action plan.

XI. REVISION OF THE ACTION PLAN

If necessary, this action plan may be revised.
